# **Financial Reports**

- Budgeted expenses: \$110,460.80 Actual: \$103,265.29 (this is YTD, not for Q3) Net: \$7,195.59
- Outstanding Liens: \$41,396.56
- Outstanding dues for the beginning of Q4: \$9908.78
- \$5,175.10 in late fees

# **Officers & Directors**

- Jodi Strausbaugh made a motion to nominate Jackie Klein to position of President Seconded by Joe and Aaron and Joe.

# **Budget Vote**
